There will be a meeting set up with Dogwood that Dr. Mullen will attend with Mrs. Wynn for new funding available to the school. Antenette Mosley from the City Council and Jesse Warren from Asheville City School Board have toured PEAK and were impressed with what is happening. The Board discussed the possibility of an MOU with Asheville City Schools. The collaboration talks with the Edington Center have ended. The Board decided to remain in the current lease with TUMC. Kidada will inform DPI of the decision.
